HopeKids Inc. only collects donor information that was submitted by the donor via online credit card donations checks third-party online giving portals direct deposits through donor-advised funds stock donations and other methods initiated by the donor.

4. How Donor Information is Stored:

HopeKids Inc. provides a secure environment for collecting donations and maintains internal controls governing the safekeeping of all confidential financial and personal information. HopeKids Inc. uses highly reputable third-party software and payment processors that use the latest industry standard security technologies to accept encrypt and store credit card and personal information.

5. How Information is Used:

HopeKids, Inc. uses your information to understand your needs and provide you with better service. Specifically, we use your information to help you complete a transaction, communicate back to you, and update you on organization happenings. Credit card numbers are used only for donation or payment processing and are not retained for other purposes. We use the comments you offer to provide you with information requested, and we take seriously each recommendation as to how we might improve communication.

6. Donor Recognition:

Unless otherwise specified HopeKids, Inc. can acknowledge and thank donors by name in public communications such as newsletters, letterhead, website, annual reports and social media. If you wish to remain anonymous in all public communications please contact us at info@hopekids.org.

7. No Sharing of Personal Information;

HopeKids, Inc. will not give, sell, rent, or lease your personal information to other organizations. We assure you that the identity of all our donors will be kept confidential. Use of donor information will be limited to the internal purposes of HopeKids, Inc. and only to further the organization activities and purposes of HopeKids, Inc. If HopeKids, Inc. is mandated by federal or state laws and agencies to disclose donor information, HopeKids, Inc. would have to comply.
